Shipping / Delivery Policy

Orders requiring freight delivery will have a delivery notice added to the order. The trucking company will call to schedule a delivery time window.

Delivery Timing

MAXXMARKA INC. does NOT reimburse for lost rental fees for forklift rentals nor do we compensate for missed deliveries or missed delivery appointments. Freight shipments are unique and therefor delivery appointments can be missed, requiring that a delivery appointment be rescheduled. All listed shipping times are estimates. Specific delivery dates and/or time frames cannot be guaranteed for any product or order. For orders with deadlines please order well in advance.
